Headstart- Our nationally accredited and state certified Head Start program provides a dynamic, comprehensive array of academic and social enrichment activities, along with essential health and supportive services for children and their families at no cost to them. Classrooms are arranged in an environment conducive to learning through the experience of play by utilizing hands-on exploration and interaction. To guide instruction, the teaching staff use Creative Curriculum, an evidence-based, and developmentally appropriate curriculum for young children. Our Head Start program services children ages three to five years old. The program had an enrollment of 220 children.

Early Head-Start - The Early Head Start program provides nationally accredited and state certified quality child care, educational and recreational services to infants and toddlers between the ages of 6 weeks to 3 years of age. Our early childhood development program encourages parent participation in building the cognitive, emotional and behavioral foundation for their children through regular meetings, communication and advocacy activities. The program supports the children and their families by serving as a safe and stimulating full day early childhood development center for working parents. The program has an enrollment of 76 children.

Family Life Services - Comprises the following programs:

Family Preservation Services - Our Family Preservation Program is an intensive, home-based counseling program that provides a comprehensive array of services for families at risk of having child(ren) removed from their home due to severe child abuse and/or neglect.

Community Center Counseling - Our Community Center Counseling program offers counseling and supportive services to individuals and families effected by Hurricane Katrina. The program also conducts life skills groups for students in several school in the community.
